5. (10 Min) Discussion and Possible Action: Sponsor Hands for Hope LA 5k Walk and Kids Healthy Activity Fair on Saturday, May 21st, 2016 from 8 a.m. to 2 p.m. in North Hollywood Park. Registration: Adults: \$20, Children (under 18): \$10. Contributing community members each get a table at activity fair. Hands for Hope LA provides support to parents of at-risk youth ages 8 to 18 from low-income, predominantly minority households, and provides after-school programs and a low-cost academic summer camp to aid in this support. A number of the at-risk youth that Hands for Hope LA helps reside within No Ho West NC boundaries. Sponsorship money goes towards marketing and advertising (printing fliers, posting newspaper ads, other media outlets, etc.), equipment (tables, chairs and tents), entertainment (bouncers, stage, sound equipment rental). Requesting \$3,000. Lydia Floyd, Executive Director, and Diane Allen, Program Director, will be at No Ho West NC General Board meeting on February 24th to discuss the program and request.
