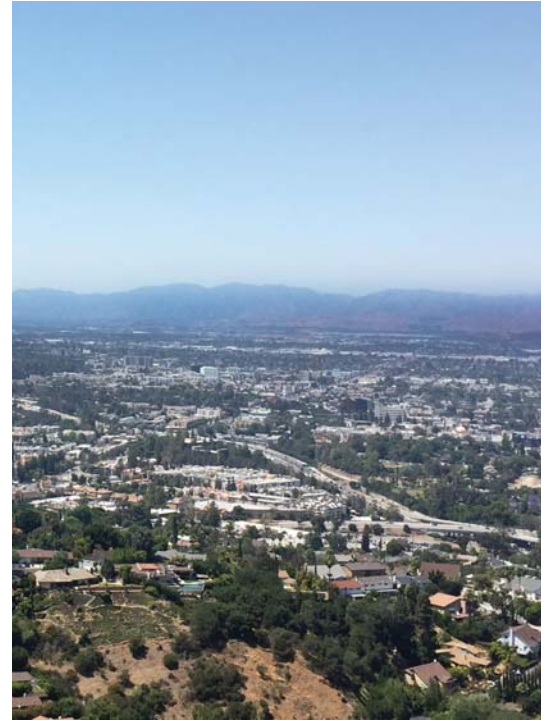


## INTRODUCTORY EVENT SCHEDULE
