

Carol Rose thanked Lorraine Diaz for her participation in movie nights.

Valley Plaza Park – Lights and cameras are to be installed on all four sides of the park.

LAPD will be staffing the Sports Complex with overtime details on Saturdays and Sundays until the end of the year.

Construction is to start on the final phase of Whitsett Soccer Field, which will include lighting and cameras for the field, Two modular buildings for restrooms and storage closets and a small office and a 30 x 30 a community classroom will be installed. 96 parking spaces will be provided.

DWP water is filtered in their filtration plant. Also 100 year old water pipes are to be replaced.

The Navigation Center on Sherman Way/Radford will be opened Mid January 2020. Center is to be rebuilt including storage bins showers, rest rooms. Case management, day labor center for the homeless will be provided. Items must be checked on every 3-5 days. Bridge Housing (85) along Ramer Street was discussed. The homeless must be referred. Section 8 and tree cutting was discussed.

There are 1700 children enrolled in the school. The campus is 28 acres.

The emphasis is on technology.

Children are encouraged to take Computer Science as an elective. Each child has their own laptop to take home.

The school has partnered with Kaiser, UCLA as a Medical Magnet.

They offer Computer Science where children learn game design and cyber security.

Their challenges are vaping and influence of gang members. Their focus is on safety in the area when children get out of school.

Dan Kagel, Advocacy Chairman - Neighborhood Council Sustainability Alliance

Presentation: How LADWP receives its power. Study of SoCal gas is asking for a 46% rate increase. Pollution problems, cost problems and reliability problems were discussed.

In 2017 the City Council asked DWP to look at what it would take to get off natural gas in general. The study is on-going.
