4) Please describe the purpose and intent of the grant.

This grant will support improvements to the Madison Middle School Teacher's Lounge. Madison MS is in the North Hollywood West NC boundaries, and is the home school for middle-school students in the NC boundaries. In order to best educate and support students, the staff and teachers that lead the education of the students must also feel supported by their school and community. By providing much needed upgrades to the Teacher's Lounge, teachers and school staff will be enabled perform their best in and outside of the classroom. A strong workforce is needed, especially as we leave the pandemic, to support the needs of the whole child. The current Teacher's Lounge is in desperate need of improvements, with needs ranging from beautification (new paint) to greater utility (new refrigerator).

Madison Middle School is the home public school for students in the North Hollywood West Neighborhood Council boundaries, and also serves students from outside the boundaries. In total, Madison MS has 150 staff who serves 1,438 students. By providing a more welcoming environment for staff, Madison will be better equipped to serve the community, particularly the students. With the partnership with the Neighborhood Council, Madison further looks forward to greater collaboration and new opportunities to support the NC and vice versa.
